The paper grades are in compliance with the rules of the

Besides, they fulfil the demands of the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of June 2021,

as well as of the

DIN EN 71, part 9 "Safety of Toys, Organic chemical compounds – Requirements", state of September 2007,

concerning the absence of not approved amines and colourants.

Thus, the paper grades **Testliner** and **Cannelure** according to the sample material submitted may be used safely for food packaging. They may stand in direct contact with dry, non-fatty and such kinds of foodstuffs which are peeled, shelled or washed before consumption and may also be used for secondary packaging.

This certificate of compliance has a validity of 2 years and consists of 4 pages. It was subsequently modified on 20 July 2023.
